6. Grant Opportunities

- Round 6 is still finishing up.
- The WISCOM county connection program through the SSMG (Statewide System Management Group) has been launched to establish a primary PSAP connection to WISCOM in every county in the state. This program was part of the original system bid for the statewide system. 19 applications have currently been submitted.
- In late fall there will be some grant funding available for reprogramming/trunking upgrades however the exact details have not yet been worked out.
- MABAS connection grant is ongoing for supplying PSAPS with IFERN basis in MABAS divisions.
- WISCOM County concept paper program continues to move along with 5 counties (Iowa, Sawyer, Taylor, Douglas, Kewaunee) and 1 city (Fond Du Lac).
- The COML/COMT credentialing exercise will take place 9/21 9/22. This is open to individuals who have completed a COML or COMT class in Wisconsin
- NECP Goal 2 about 50% of counties in the state have submitted their information. Looking to have the rest completed and submitted before September 1.
