SUBJECT: Adjustment of the Public Assistance Program's
Countywide Per Capita Impact Indicator

Attached for your information and dissemination, is a copy of the Federal Register Notice, announcing the annual Consumer Price Index (CPI) adjustment of the countywide per capita impact indicator under the Public Assistance program. In assessing damages for area designations under 44 CFR 206.40(b), FEMA uses a countywide per capita indicator to evaluate the impact of the disaster at the county level. The countywide per capita indicator is adjusted to reflect the annual change in the CPI for all Urban Consumers published by the Department of Labor.

Effective October 1, 2018, the countywide per capita indicator is \$3.78, which reflects an increase in the CPI of 2.7 percent for the 12-month period that ended in August 2018.

This change applies to all disasters declared on or after October 1, 2018. Please ensure that all members of your staff are aware of this change and its applicability.

SUMMARY: FEMA gives notice that the countywide per capita impact indicator under the Public Assistance program for disasters declared on or after October 1, 2018, will be increased.

DATE: This adjustment applies to major disasters declared on or after October 1, 2018.



SUPPLEMENTARY INFORMATION: In assessing damages for area designations under 44 CFR 206.40(b), FEMA uses a countywide per capita indicator to evaluate the impact of the disaster at the county level. FEMA will adjust the countywide per capita impact indicator under the Public Assistance program to reflect annual changes in the Consumer Price Index for All Urban Consumers published by the Department of Labor.

FEMA gives notice of an increase in the countywide per capita impact indicator to \$3.78 for all disasters declared on or after October 1, 2018.

FEMA bases the adjustment on an increase in the Consumer Price Index for All Urban Consumers of 2.7 percent for the 12-month period that ended in August 2018. The Bureau of Labor Statistics of the U.S. Department of Labor released the information on September 13, 2018.
