SUBJECT: Signature Blocks – TAG Policy Memorandum 15

1. This memorandum clarifies the signature blocks for the Wisconsin National Guard (WING) leadership in accordance with AR 25-50 (Preparing and Managing Correspondence), dated 10 October 2020, paragraphs 6-4 and 6-5c(11) or AFH 33-337 (The Tongue and Quill), dated 9 December 2021. Directors may authorize subordinates to sign for them in accordance with the above regulations. Delegation of signature authority must be in writing and a copy submitted to either Chief of Staff, Army or Director of Staff, Air.

2. The Adjutant General's signature block for all correspondence listed above and for all Wisconsin National Guard (WING) correspondence is as follows:


